PHVA VEHICLE STICKERS ISSUANCE GUIDELINES

I. PHVA POLICY AND GUIDELINES

- 1. Strict maximum of eight (8) Village Sticker per house owner. The sticker privilege shall be strictly limited only to residents/property owners and their immediate family members. This means parents, children, and siblings only. Relatives and friends are not entitled to Village Stickers.
- 2. Owners of vehicles bearing a PHVA Sticker must follow all traffic rules and regulations of the issuing village. Motorists must at all times, show respect and courteous attitude to the security officers implementing the traffic rules and regulations
- 3. Fines imposed for any traffic violation must be settled promptly at the PHVA Admin Office.
- 4. Vehicles Stickers are non-transferable. Removal of sticker and affixing it to another vehicle is strictly prohibited. Penalty for illegally transferring a sticker to another vehicle is P10,000.00.
- 5. For Simplication, the "PHVA Vehicle Sticker" in our forms, rules and regulation, processes and procedures, refer to the PHVA Vehicle Sticker used to identify and authorize vehicles for entry into the Village.
- 6. Tha PHVA Vehicle Sticker remains the property of PHVA.
- 7. Anyone in possession of a PHVA Vehicle Sticker acquired through illegal means, or in possession of fake stickers, shall be subject to, but not limited to, fines, permanent ban from entering the village, and legal prosecution.
- 8. The PHVA Vehicle Sticker will only be issued at the PHVA Admin Office.
- 9. If the vehicle is to be sold or disposed of, the PHVA Vehicle Sticker must be removed and surrendered to the PHVA office **BEFORE** the vehicle is turned over to a new owner
- 10. PHVA Vehicle Stickers will only be issued only to members/residents who are updated in the payment of their membership dues and other assessments. Members on deliquent status are not entitled to issuance of PHVA Vehicle Stickers
- 11. Members/residents who were previously cited for traffic violation and who have not paid yet the fines/penalties must first settle the unpaid fines before issuance of a new sticker to the particular vehicle subject of traffic citation is processed.
- 12. No sticker will be issued to commercial vehicles or to vehicles with business name, logo, product/service markings or with telephone numbers, email address, or other contact information. This includes large trucks, vehicles with drop side, and heavy motor vehicles used for transporting goods and materials.
- 13. Residents are responsible for the proper use of the vehicles listed in this form while while they are on the premises of Plantation Hills Village including, but not limited to, the integrity of the persons aboard the vehicles and propriety of materials being transported, which may be subjected to proper inspection by security officers as deemed necessary.
- 14. In the event of an accident, collision, or incident involving vehicles listed in this form that necessitates an investigation by law enforcement agencies, PHVA shall have the right to provide all relevant information on the ownership and details of the vehicle involved aid in the investigation and its speedy resolution

II. Application Requirements

- 1. Vehicle Certificate of Registration (CR) and latest Official Receipt (OR)
- 2. If vehicle CR or OR is not yet available, Sales Invoice and Delivery Receipt
- 3. For vehicles previously registered with PHVA, we will try and provide you a list for easier renewal. CR and OR will not be required if we have these vehicles on record.
- 4. For vehicles registered under a company, corporation, organization, or embassy, we require an official certificate issued by the company's Corporate Secretary or authorized signatory of the Embassy stating that the vehicle is assigned for the use of the resident.
